India-EU Bilateral Trade

India-EU Bilateral Trade in Goods (2024)

Bilateral trade has been a key pillar of the India-EU relationship. According to official EU statistics, India's total trade in goods with the EU stood at **€110.3 billion** in 2024, comprising Indian exports of €63.5 billion and imports of €46.8 billion. This represented a 2.6% decline compared to €113.2 billion in 2023. Despite the overall dip, the trade balance remained in India's favor, with a surplus of €16.7 billion in 2024.

Separately, financial-year-wise data from India's Department of Commerce shows that bilateral trade in goods between India and the EU for FY 2023-24 stood at USD 135.02 billion, reflecting a 0.64% decline from USD 135.89 billion in FY 2022-23. Despite this, the EU remains India's largest trading partner in goods for the financial year 2023-24.

In 2023, India was the ninth largest trading partner for EU's exports of goods (1.89%) and also the ninth largest partner for EU's imports of goods (2.58%). India's percentage share in EU's global total bilateral trade in 2023 stood at 2.19%.

Bilateral Trade in Services (2023)

From 2019 to 2023, India-EU bilateral trade in services exhibited steady growth, with Indian exports increasing from **€18.1 billion in 2019 to €33.8 billion in 2023**, marking a 10.1% rise in 2023 compared to the previous year. Imports from the EU however saw a small decrease, reaching **€26.0 billion in 2023**, reflecting a **2.6% decrease over 2022**. The trade balance consistently remained in India's favor, peaking at €7.8 billion in 2023, the highest in five years. While the overall trade saw fluctuations, particularly during the pandemic, it rebounded strongly in 2021 and 2022, before stabilizing in 2023.

FDI Flows from EU to India

As per Department for the Promotion of Trade and Internal Trade (DPIIT) data, the EU's cumulative FDI inflows to India during April 2000 to December 2024 totalled at **USD119.256 billion** and represented a share of 16.6% of the cumulative amount of FDI Equity Inflow from all countries which stood at \$708.654bn.

The top investors from EU are the Netherlands (USD 52.7bn), Germany (USD 15.0bn) followed by Cyprus (USD 14.6bn), France (USD 11.7bn), and Luxembourg (USD 5.1bn)

India - Belgium Bilateral Trade in Goods (2024)

India's bilateral trade in goods with Belgium stood at **€9.8bn** in 2024 comprising Indian exports worth of **€5.9bn** and imports worth **€3.9bn**. However the bilateral trade of **€** 9.8bn in 2024 registered a fall by 12.5% compared to **€11.2bn** of 2023. Indian exports worth **€5.9bn** in 2024 registered a fall of 6.3% compared to 2023 and Indian imports of **€3.9bn** registered a sharp decline by 20.4% compared to 2023. The balance of trade in 2023 was in favor of India by **€** 2.0bn.

India's bilateral trade with Luxembourg stood at \in 94.6 million in 2024 comprising Indian exports worth of \in 31.6mn and imports worth \in 63.0mn. However the bilateral trade of \in 94.6mn in 2024 registered a decrease by 20.2% compared to \in 118.57mn in 2023. Indian exports worth \in 31.6mn in 2024 registered a decrease of 21.6% compared to 2023 and Indian imports of 63.0mn also registered distinct decrease by 19.5% compared to 2023.The balance of trade in 2023 was in favour of Luxembourg by \in 31.40mn.
